# What is the 2nd Replacement Local Development Plan (2RLDP)?

The 2nd Replacement Caerphilly County Borough Local Development Plan up to 2035 (2RLDP) will allocate land for development, designate areas for protection, and act as the starting point in the assessment of planning applications.

# What is the Preferred Strategy?

### The Preferred Strategy is a document that:

- Identifies important issues, challenges and opportunities
- Develops a vision and a set of objectives
- Sets out the level of growth (housing and employment) and the approximate spatial distribution of that growth
- Sets out strategic policies

#### It does not:

- Allocate sites for development (except, perhaps, large and important 'strategic sites')
- Identify settlement boundaries or areas to be protected
- Set out detailed development-management policies
- Assess Candidate Sites

### What is the vision?

#### By the end of the plan period, the development strategy will have:

Addressed the economic and social challenges raised by Covid-19, Brexit and changes in employment and retailing patterns

Facilitated an increased number of jobs & economic growth

Exploited existing strengths in manufacturing and the foundational economy (basic goods and services)

Created vibrant town centres with diverse uses

Helped to incorporate 'blue' (water elements) and 'green' (natural and semi-natural features) infrastructure into development

Addressed the housing crisis through the provision of affordable and market housing, developed a wide range and choice of housing and ensured that all residents have access to a good quality home in the right locations

Built on the diverse and distinct character of the towns and villages in the County Borough, having put placemaking principles at the heart of design and encouraged cultural richness and diversity

Enhanced the strategic network of recreation, leisure, education and community facilities, strengthened communities and engendered a better quality of life for all

### How much growth?

General population to increase by approximately 10,700 (including 4,100 working-age people).

> 6,750 dwellings (including at least 1,360 affordable dwellings).

44.5 hectares of land for employment uses.



# Where will the growth take place?

- The Preferred Strategy has three main parts:
  - South Wales Metro Investment Focus
  - Town Centre(s) First
  - Key Strategic Site
- Growth and new development will be directed to Principal and Local Centres (see the settlement hierarchy below), nearly all of which have rail or major bus stations
- During the plan period, 1,200 dwellings will be built on a strategic site, Parc Gwernau, Maesycwmmer. After the plan period, a further 1,500 dwellings will be built on it

Comments on the Preferred Strategy and supporting documents must be submitted to the Council by the closing date. <u>Comments received after the closing</u> <u>date will not be accepted and will not be considered</u>
- The Preferred Strategy and its supporting documents are available for inspection on the Council's websites, and copies of the Preferred Strategy have been placed in each of the libraries throughout the County Borough

# **Next Steps**

- Seek approval of Preferred Strategy by end of 2022
- Consultation and stakeholder engagement
- Finalise the 2RLDP and place it on deposit (provisional site allocations will be revealed at this stage)
- Statutory six-week consultation and engagement period in summer 2023
- Submit Deposit 2RLDP to Welsh Government
- Public examination (led by a planning inspector) of 2RLDP
- Inspector to issue a binding report
- Once adopted, the 2RLDP will replace the existing Adopted LDP
